COLLECTION AND PROCESSING OF PERSONAL DATA - PURPOSE OF PROCESSING:

Upon entering the Camping Antiparos accommodation during the checkin process at the reception, you will deliver us your passport and we will collect the following information:

- Your Name , Passport number , E-mail address, Your phone number, The number of children who accompany you and will also spend the night in our area and are registered with your Passport at checkin ,Any other information necessary for the checkin process .

The above information constitutes personal data, in accordance with Regulation 2016/679 (Article 4 No. 1), which stipulates that personal data is any information concerning an identified or identifiable natural person ("data subject").

The collection of this information is necessary, in order to verify the identity of our client, to communicate with you, to issue our tax receipts but also for the proper management of any case of Covid-19.

The processing of your personal data is done for the provision of our services and for the health and safety of our customers and our staff and is necessary for the fulfillment of the obligations arising from the contract between us.

The retention time of your personal data is for the period of three (3) months, ie from the opening day of Camping Antiparos on 15/6/2020 due to the pandemic until its expiration in September 2020.

We do not pass on your personal data to third parties except for the protection of the interests of Camping Antiparos in case of abnormal development of the contract between us in courts or other public authorities or in case we are asked for public health reasons by the competent authorities. Others to whom your personal data is transmitted in this way are not entitled to use it for other purposes.

With the delivery of your Passport during checkin at Camping Antiparos you declare that you accept the processing of your personal data and you approve the above actions of Camping Antiparos until the maximum time as described above
